How do inverters provide grid services?

In order to provide grid services, inverters need to have sources of power that they can control. This could be either generation, such as a solar panel that is currently producing electricity, or storage, like a battery system that can be used to provide power that was previously stored.

How do grid-following inverters work?

Traditional "grid-following" inverters require an outside signal from the electrical grid to determine when the switching will occur in order to produce a sine wave that can be injected into the power grid. In these systems, the power from the grid provides a signal that the inverter tries to match.

How does a grid forming inverter work?

Grid-forming inverters can start up a grid if it goes down--a process known as black start. Traditional "grid-following" inverters require an outside signal from the electrical grid to determine when the switching will occur in order to produce a sine wave that can be injected into the power grid.

How does a solar-plus-battery storage system work?

Solar-plus-battery storage systems rely on advanced inverters to operate without any support from the grid in case of outages, if they are designed to do so. Historically, electrical power has been predominantly generated by burning a fuel and creating steam, which then spins a turbine generator, which creates electricity.

All shipping container solar systems must comply with local building and electrical codes. This includes proper grounding, GFCI protection, and the use of UL-listed components.
